

During the month of March 2025, there were 66 outbreaks reported in West Virginia and all were confirmed to be outbreaks or clusters of disease. Forty-four occurred in healthcare facilities, twelve in schools, six in daycares, three in food and hospitality and one residential facility.

Of the 44 healthcare associated outbreaks, 38 were reported from long term care facilities (LTCF), 4 from assisted living facilities, 1 from a hospital and 1 from a dialysis center.

The rest of this report describes the types and settings of the outbreaks. All data provided is provisional as some outbreaks may still be under investigation.



Figure 1 illustrates confirmed outbreaks by type.








Figure 2 illustrates the number of outbreaks per region by type.







Figure 3 displays the number of outbreaks by region.
