

West Virginia Harm Reduction Programs At-A-Glance

Certified vs. Non-certified:

Harm Reduction Programs (HRPs) have been operating in West Virginia since 2011. HRPs provide sterile syringes, collecting non-sterile (used) syringes and acting as points of access to prevention, testing and treatment for blood-borne diseases, as well as providing family planning and referrals to medical treatment and social services.

The West Virginia Department of Health and Human Resources (WV DHHR), Bureau for Public Health's [The Harm Reduction Program Guidelines and Certification Procedure](#) (revised August 27, 2018) outlines the minimum requirements for West Virginia HRPs to receive funding through WV DHHR. Certification is not a requirement for HRPs to operate in West Virginia. However, it does ensure HRPs follow core guidelines essential to successful program implementation.

Transaction Models:

- **One-for-One:** For every non-sterile syringe returned to the HRP, the participant receives a sterile syringe in return.
- **One-for-One Plus:** It is possible for the participant to receive more than one sterile syringe, for every non-sterile syringe returned to the HRP. It is also possible that the number is pre-defined by the program policy. Typically, there is still a requirement that a participant turns in non-sterile syringes to receive sterile ones; however, there is more flexibility when participants do not have enough—or possible any—non-sterile syringes to exchange.
- **Needs-Based:** Regardless of the number of non-sterile syringes returned, there is no limit on the number of syringes a participant may receive. Participants are encouraged—but not required—to return non-sterile syringes to receive sterile ones. The number dispensed is determined by the participant's reported usage. Depending on the program policy, there may or may not be a set limit on number of syringes dispensed per transaction.

Service Delivery Method:

- **Fixed Site:** Harm reduction services provided at a fixed location, such as a local health department or health clinics.
- **Mobile Delivery:** Syringe exchange services are conducted using a van or other, similar vehicle. Stops are made at designated locations at specific times. Mobile routes typically require pre-approval and authorization from community stakeholders.
- **Both (Fixed and Mobile Delivery):** Harm reduction services are provided at both a fixed site location, as well as through mobile delivery services.
