This alert is to provide an update on MERS-CoV infection in the United States. The first two imported U.S. cases of MERS-CoV have been confirmed. These cases were healthcare workers who traveled from Saudi Arabia to the United States. In both instances, the cases developed respiratory symptoms during or shortly after travel to the U.S. The cases represent a very low risk of transmission to the general public. A third case of MERS-CoV, identified during the investigation, had contact with the first U.S. case. At this time, no suspected or confirmed cases have been reported in West Virginia. Standard, contact and airborne precautions should be used for any suspect or confirmed cases.

The West Virginia Bureau for Public Health would like to bring the following key points to your attention:

- Providers should maintain heightened awareness for possible cases of MERS-CoV and report immediately, by phone, to their local health department any person who meet the following criteria:
 - A. Fever and pneumonia or acute respiratory distress syndrome (based on clinical or radiologic evidence) **AND** any of the following:
 - ✓ History of travel from countries in or near the Arabian Peninsula within 14 days before symptom onset. OR
 - ✓ Close contact with a symptomatic traveler who developed fever and acute respiratory illness (not necessarily pneumonia) within 14 days after travelling from countries in or near the Arabian Peninsula, OR
 - Is a member of cluster of patients with severe acute respiratory illness (e.g. fever and pneumonia \checkmark requiring hospitalization) of unknown etiology

OR:

- B. Close contact of a confirmed or probable case of MERS-CoV
- Contact the local health department to obtain appropriate diagnostic recommendations. Your local health department will work with you to evaluate your patient's clinical status and exposure history. Testing is available ONLY at the West Virginia Office of Laboratory Services (OLS) and must be coordinated through your local health department.
