

## Just Bobbin' Along

In the new fiscal year, you will start to see noticeable upgrades to the operating systems that drive WVSIIS. Through a cooperative agreement with the CDC, DIS has been working for the last year to modernize the immunization database with partner STChealth. Coming soon, you will see changes to the landing page and functionality of the systems, with new modules to assist with vaccine ordering and inventory management. In addition to the overall upgrades and system improvements, DIS has also developed a new series of training modules to assist with not only learning the new systems, but also to train future staff on all the elements and features of WVSIIS. The training modules will be located on a new learning management system, called WeVaX. WeVax will provide 24-hour access to all documentation, training material, user manuals, and communications between the DIS team and the medical staff of West Virginia. DIS appreciates its partnership with the CDC and STChealth in rolling out this \$2 million upgrade.

### To ensure the transition runs smoothly:

- All staff members should be current and have a WVSIIS login ID, password, and current email address.
- Deactivate staff members no longer in your facility.
- Update the vaccine coordinator and back up vaccine coordinator.
- Check if your vaccine inventory is current.
- Take the time to update the users and inventory in your facility or reach out to the WVSIIS team for assistance.
