

Outbreak Report for January 2026 West Virginia

During the month of January 2026, there were one hundred and twenty-two outbreaks reported in West Virginia and one hundred nineteen were confirmed to be outbreaks or clusters of disease. The reported settings for these outbreaks included 57 long-term care facilities (LTCF), 32 schools, 12 daycares, 6 assisted living facilities, and 5 psychiatric hospitals. There were also 3 outbreaks in congregate living facilities, including a housing authority site and other residential facilities. The remaining reports included 2 community-based clusters, 1 other healthcare setting, and 1 in food and hospitality.

The rest of this report describes the types and settings of the outbreaks. All data provided is provisional as some outbreaks may still be under investigation.

Figure 1 illustrates confirmed outbreaks by type.

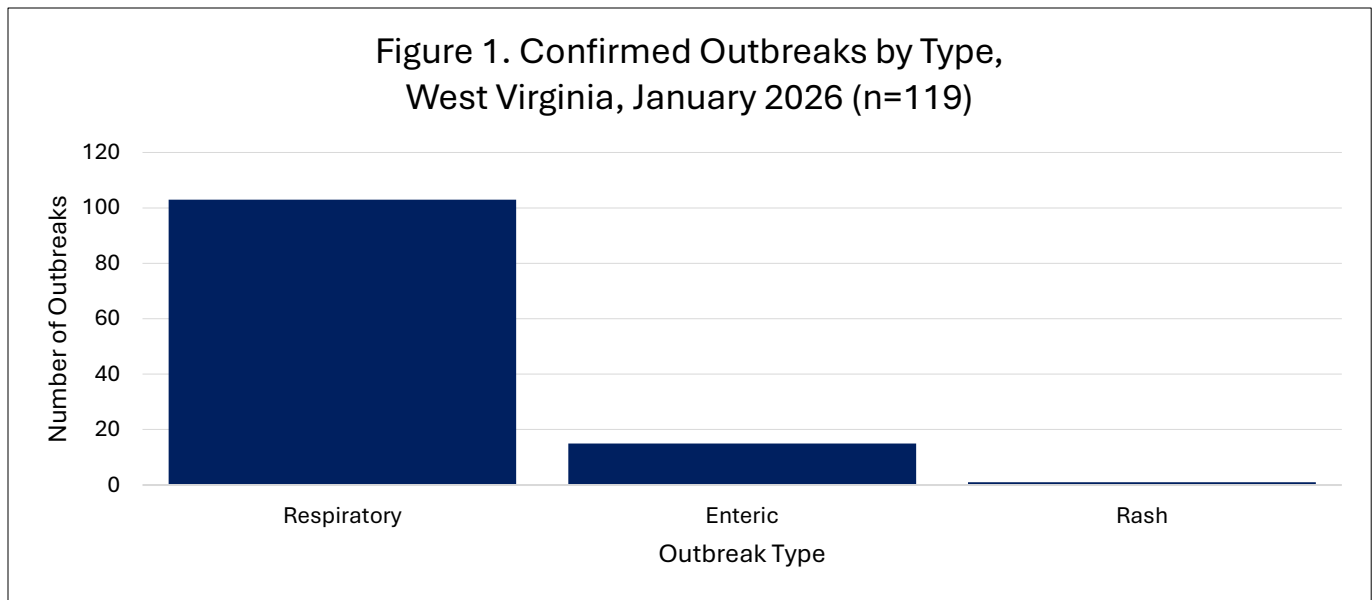
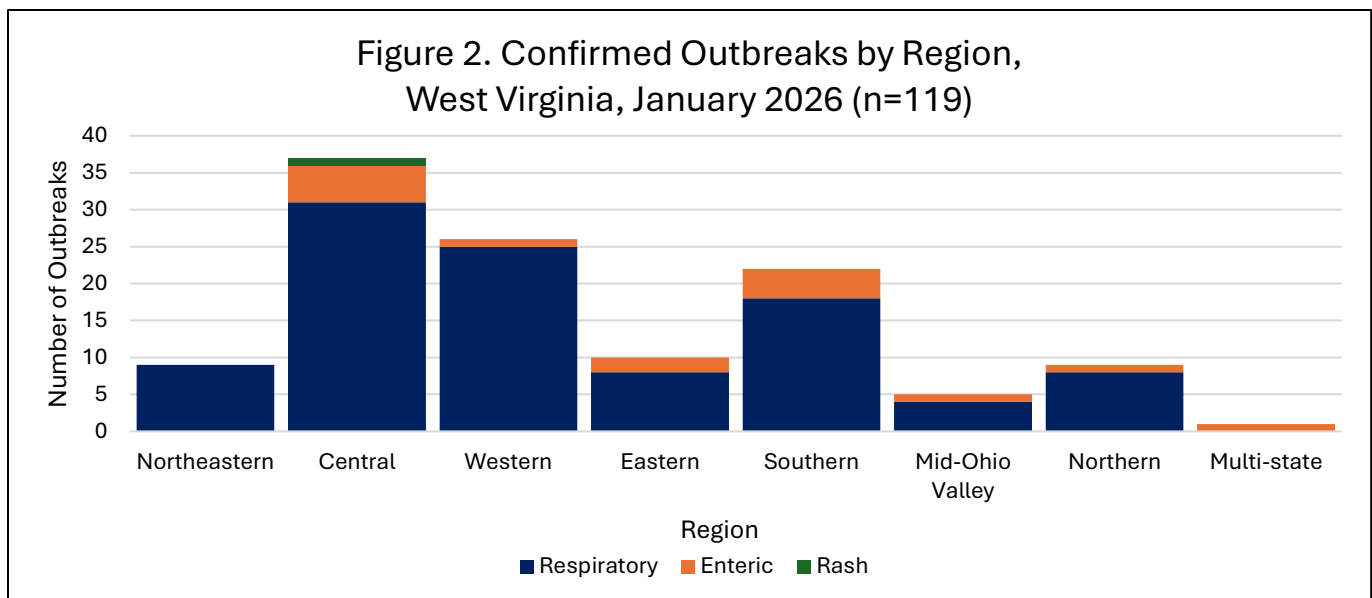
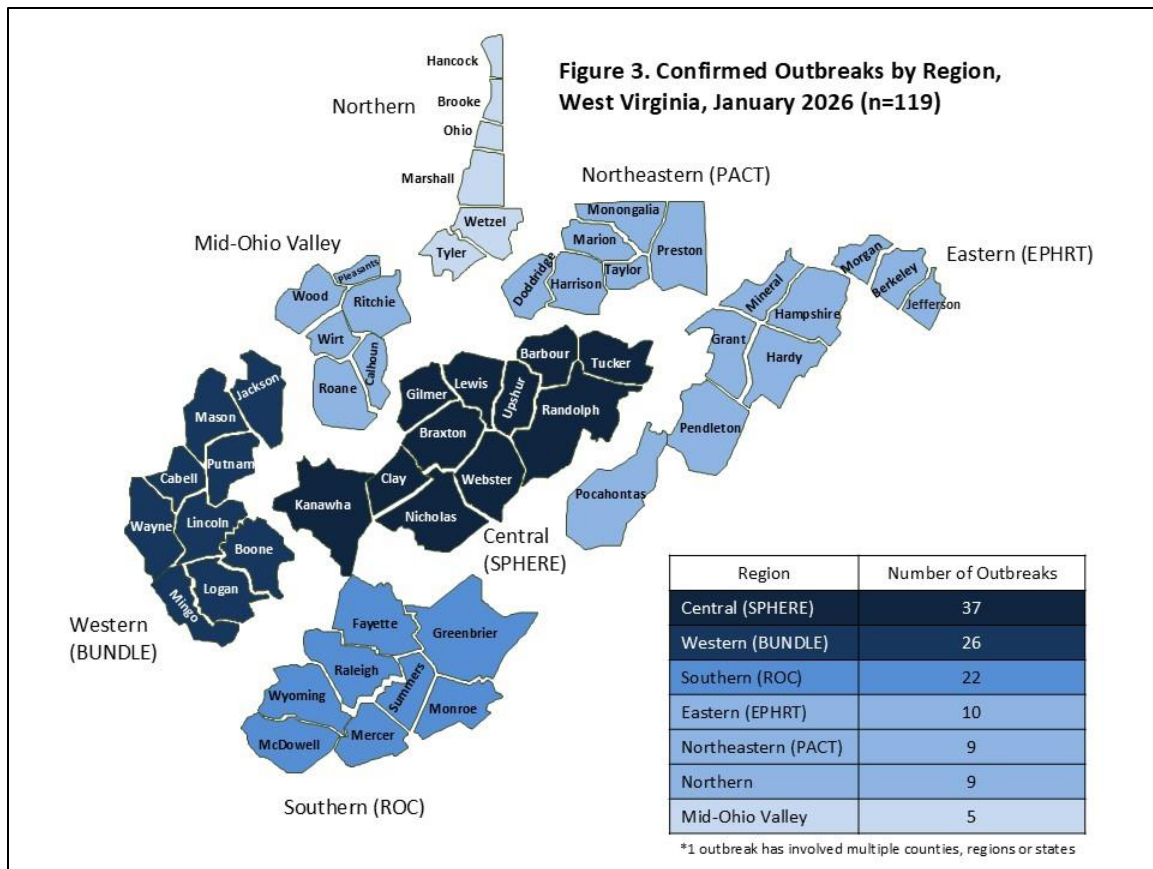


Figure 2 illustrates the number of outbreaks per region by type.



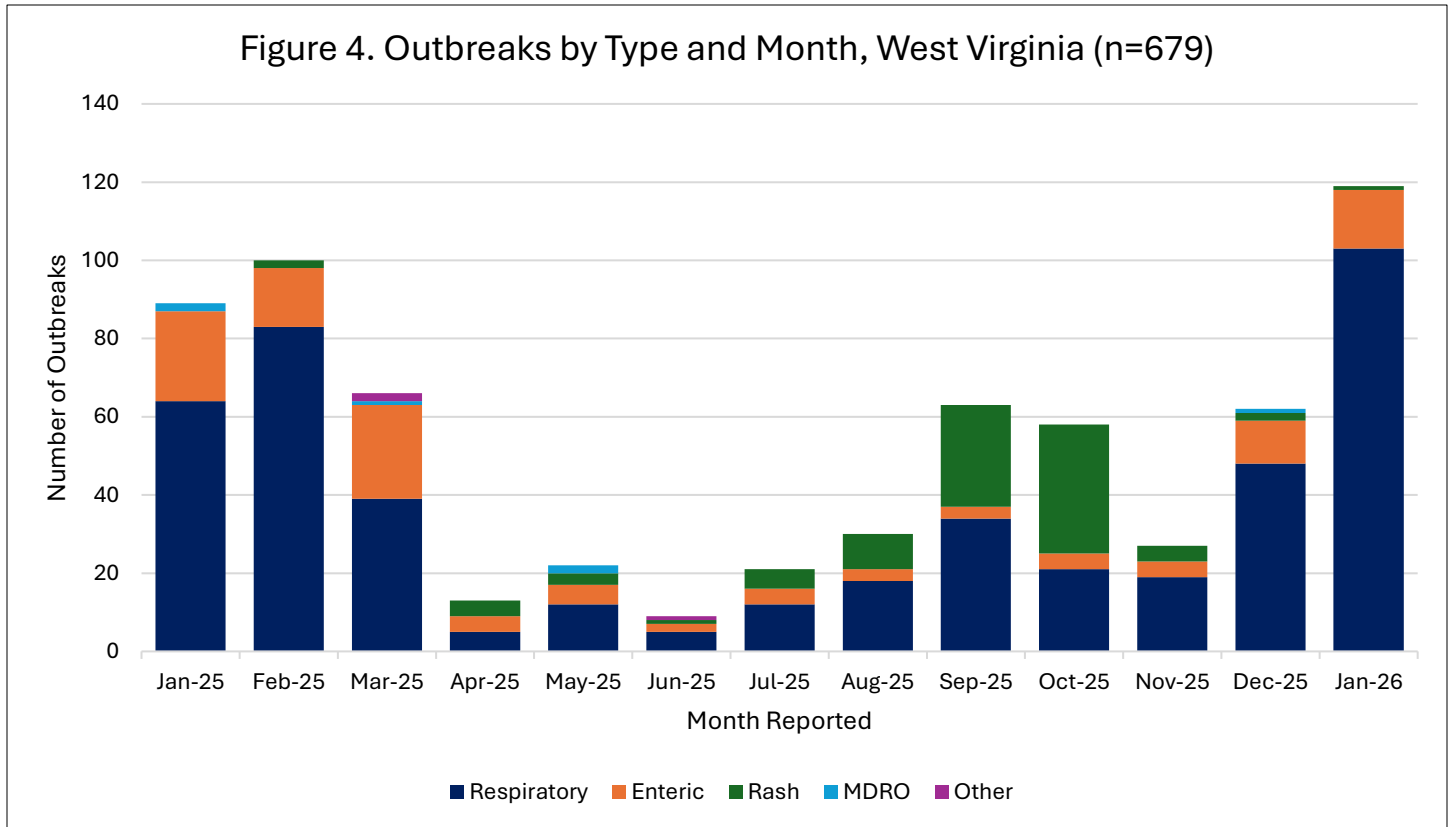
