## HEALTH ALERT #172 Reporting of COVID-19 Deaths

TO: West Virginia Healthcare Providers, Hospitals and Other Healthcare Facilities

As the West Virginia Department of Health and Human Resources (DHHR), Bureau for Public Health (BPH) continues to respond to the novel coronavirus disease (COVID-19), BPH would like to remind everyone about COVID-19 death reporting.

COVID-19 remains a Category 1A Reportable Condition in West Virginia (Order 64 CSR-7). Deaths related to COVID-19 are **immediately** reportable to the local health department (LHD) for the patient's county of residence by telephone. There are no exceptions.

Upon reporting a COVID-19 related death to the LHD by telephone, you must follow-up by completing the form – *Report A Death Associated With Coronavirus Disease 2019 (COVID-19)* and sending it by secure facsimile to the respective LHD the same day. Instructions for reporting COVID-19 deaths and a copy of the COVID-19 Death Report form can be found on our website at <a href="https://www.coronavirus.wv.gov">www.coronavirus.wv.gov</a> under Providers.

Timely reporting of COVID-19 deaths is essential to anticipate and respond to the disease. The timeliness of receiving death reports is crucial in determining our data when it comes to the DHHR Dashboard and, in turn, determining our future alert system of the state. Although death certificates are certified and submitted to the West Virginia Health Statistics Center, we typically encounter a two-week lag from the report of the death via death certificate and the date of death. To avoid a lag in reporting a COVID-19 related death, we are requesting all healthcare providers and partners (i.e. coroners, funeral directors, medical examiners, etc.) notify their LHD as soon as they are aware the death is COVID-19 related.
